You must contact the company of your choice and enter into an agreement for representatino before listing them as your registered agent.

To provide registerd agent service in Idaho, you must be an individual who can be located at a physical address in the state, or a business entity who is field with the Secretary of State's office to transact business in Idaho and have a physical office in thestate. Assumed Business Name entities cannot function as registered agents since they are not considered to be legal entities in their own right under Idaho statute.
