ARTICLES OF AMENDMENT

The undersigned, being President and Secretary of Steamboat Bay Addition, Inc., hereby adopt the following Articles of Amendment for such corporation:

I.

Article III of the original Articles of Incorporation is amended to read as follows:

"The address of the registered office of the corporation shall be 3239 8th Street, Lewiston, Idaho 83501. The name of the registered agent of the corporation at that address is Harold J. Grimes."

II.

Article V of the original Articles of Incorporation is amended to read as follows:

"Pecuniary gain or profit is not an objective of this corporation. No officer, member, or director of this corporation shall be entitled to any remuneration by virtue of being an officer, member, or director of this corporation except in the event said officer, member, or director does work for and on behalf of the corporation which would otherwise require the employment of individuals at an hourly wage to perform the same service."

III.

Article VI of the original Articles of Incorporation is amended to read as follows:

"This corporation is organized upon a non-stock, certificate of membership basis. Such memberships shall be non-transferable, non-assignable and non-dividend bearing."

IV.

Article VII of the original Articles of Incorporation is hereby deleted.

V.

Article IX of the original Articles of Incorporation is amended to read as follows:
