## ARTICLES OF INCORPORATION SEC. OF STATE

## KNOW ALL MEN BY THESE PRESENTS:

The undersigned, all citizens of the United States of America, each being over the age of 18 years, do hereby associate ourselves together for the purpose of forming a corporation under and pursuant to the provisions of the laws of the State of Idaho, for the purposes expressed in the following Articles, and do hereby adopt the following Articles of Incorporation:

ARTICLE 1: NAME OF CORPORATION: The name of the Corporation shall be: Landowners Technology, Inc.

ARTICLE 2: PURPOSES: The Corporation is organized for the purpose of the transaction of any or all lawful business for which Corporations may be incorporated under the "Idaho Business Corporation Act."

ARTICLE 3: TERM: The corporation is to have perpetual existence.

ARTICLE 4: REGISTERED OFFICE & REGISTERED AGENT: The registered office of the corporation shall be located at Rt. #1 Murtaugh, Idaho 83344. The registered agent for the corporation shall be Howard Conrad, whose business office is identical with the registered office of the corporation.

Voting of the stock shall be cumulative.

Any director individually may be a party to or may be pecuniarily or otherwise interested in a contract or transaction of the corporation and any directors of the corporation who are so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the Corporation which shall authorize such contract or transaction and may vote thereon to authorize such contract or transaction with the same right, force and effect as if he were not such director or officer of The same shall such corporation and not so interested therein. apply if any officer or director of this corporation shall be interested in any other form of business entity dealing with this corporation.
