1 AMENDMENT TO ARTICLE OF INCORPORATION

2 OF

5 WHEREAS, at a meeting of the stockholders of the above  
6 named corporation, duly and regularly called and held at 2:00  
7 o'clock P. M. the 1st day of August, 1958, at the principal office  
8 of the corporation in the City of Boise, Idaho, at which there were  
9 present and voting in person, or by proxy, stockholders owning two-  
10 thirds of the capital stock of the said corporation, there was pre-  
11 sented and adopted by unanimous vote the following resolution amend-  
12 ing the Articles of Incorporation of said corporation, to-wit:

13 "RESOLVED, That Article III of the Articles of  
14 Incorporation of Idaho Service Company, Inc. be  
15 and the same is hereby amended to read as fol-  
16 lows:

16 ARTICLE III.

29 resolution aforesaid, do hereby execute this Amendment of the  
30 Articles of Incorporation amending Article III of the original  
31 Articles of Incorporation of this corporation to read as follows:

Canyon County, Idaho.

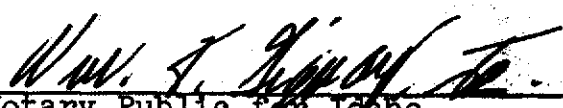
