

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, FRED E. LUKENS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the nineteenth day of November 1930, original articles of amendment, as provided by Section a 55 and 54 of Chapter 262 of the 1929 Session Laws of the State of Idaho, amending Article Fifth, changing the number of directors from seven (7) to not less than three (5) nor more than fifteen (15),

follows:
