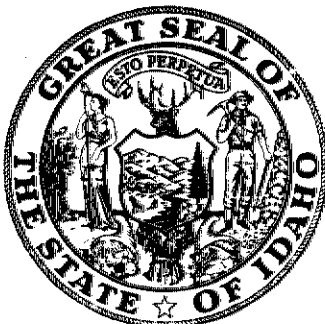

1. **Name.** The name of the corporation is Weeks and Vietri Case Management Service, P.A.
2. **Duration.** The duration of this corporation shall be perpetual.
