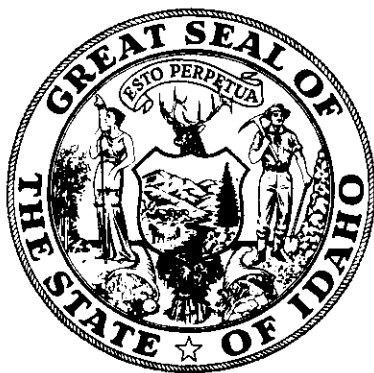

FIRST: The name of this corporation is PARK, INC.,

SECOND: Its registered office in the State of Idaho is to be located at Route 4, Box 730, Rathdrum, County of Kootenai. The registered agent in charge thereof is Chester R. Park, address "same as above".

THIRD: The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, are to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Idaho.

FOURTH: The amount of total authorized capital stock of the corporation is divided into Fifty (50) shares of no-par value.

FIFTH: The name and mailing address of the incorporator is as follows:

SIXTH: The powers of the incorporator are to terminate upon filing the certificate of incorporation, and the name and mailing addresses of the persons who are to serve as managing stockholders until their successors are elected are as follows:

SEVENTH: All of the corporation's issued stock, exclusive of treasury shares, shall be held of record by not more than thirty (30) persons.

EIGHTH: All of the issued stock of all classes shall be subject to the following restrictions on transfer permitted by Section 30 of the General Corporation Law of Idaho.

Each stockholder shall offer to the Corporation or to other stockholders of the corporation a thirty (30) day "first refusal" option to purchase his stock should he elect to sell his stock.

NINTH: The corporation shall make no offering of any of its stock of any class which would constitute a "Public Offering" within the meaning of the United States Securities Act of 1933, as it may be amended from time to time.

WE, THE UNDERSIGNED, for the purpose of forming a corporation under the laws of the STATE OF IDAHO, do make, file and record this certificate, and do certify that the facts herein stated are true; and we have accordingly hereunto set our hands.
