ARTICLES OF INCORPORATION

We, the undersigned, / have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt Articles of Incorporation as follows:

I

The name of the proposed corporation is WESTGATE LANES, INC.

II

The purposes of the corporation are: To purchase, acquire, own, manage, and maintain bowling lanes and related amusements of every kind and nature, including the maintenance of the necessary food operation and dispensing service, and to do all acts and things incident or necessary to the purposes herein, including the maintenance of bowling lanes, bowling balls, pins, and other bowling equipment, and to own, sell, hold, lease, equip, maintain and operate such business, or any properties necessarily incident thereto. ✓

III

The duration of this corporation is unlimited.

IV

The location and post office address of the registered office of the corporation in the State of Idaho is 1306 Santa Maria Drive, Boise, Idaho.

V

The total authorized number of par value shares is 1,000 shares. The aggregate par value of the total authorized number of par value shares is \$100,000.

The stock of the corporation is divided into 100 shares of common stock all of the same class and all with voting rights. ✓

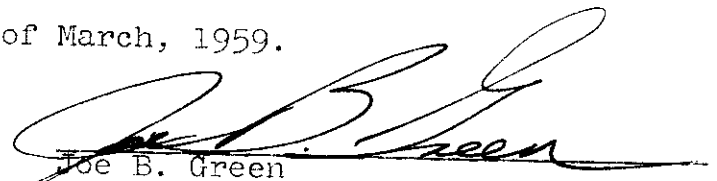

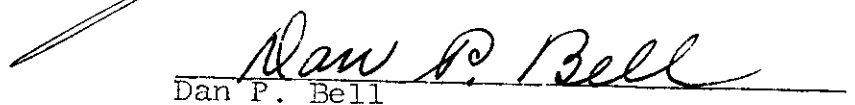

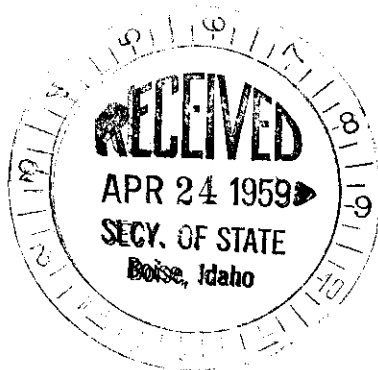
