ARTICLES OF INCORPORATION

COMMERCIAL TIRE OF POCATELLO, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age, citizens of the United States and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify as follows:

ARTICLE I

The name of this corporation shall be COMMERCIAL TIRE OF POCATELLO, INC.

ARTICLE II

The purposes for which this corporation is formed are: for any and all lawful purposes.

The foregoing shall be construed as objects and powers and the enumeration thereof shall not be held to limit or restrain in any manner the general powers now or hereafter conferred on this corporation by the statutes of the State of Idaho.

ARTICLE III

The existence of this corporation shall be perpetual.

ARTICLE IV

The principal office or place of business of this corporation shall be 1900 South Cole Road, Boise, Idaho, but the corporation may maintain an office in such towns, cities and places outside the State of Idaho as the Board of Directors may from time to time determine, or as may be designated by the By-Laws of said corporation. The corporate agent at said office is J. R. Schwenkfelder.

ARTICLE V

The total amount of the authorized capital stock of this corporation is \$100,000.00 consisting of 100,000 shares of common stock with a par value of \$1.00 per share.

ARTICLE VI

The members of the governing board of this corporation are styled as "Directors," and the Board of Directors shall consist of at least one, but not more than seven, as may be provided by the By-Laws of the corporation.

ARTICLE VII

The capital stock of this corporation shall be non-assessable; and the private property of the shareholders, and each of them, shall not be subject to assessment or be liable for the debts, obligations or liabilities of this corporation.

ARTICLE VIII
