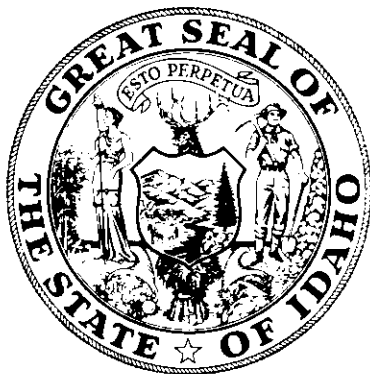

ARTICLES OF AMENDMENT
to the
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Bradley Park, Inc. has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is Bradley Park, Inc.

II

The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on June 14, 1982, in the manner prescribed by the Idaho Business Corporation Act:

Article VIII of the Articles of Incorporation shall be amended to read as follows:

ARTICLE VIII

No stockholder of this corporation shall transfer, assign or sell his stock to any person or corporation who is not a stockholder of this corporation without first offering the same to the corporation for purchase. Said offer to be in writing given at least sixty (60) days prior to any such sale. The corporation shall have the right during said sixty-day period to purchase such stock at a price 10 percent less than that fixed and determined by appraisers in accordance with the appraisal provisions of Idaho Code 30-150, Section 2.

III

The number of shares of the corporation outstanding at the time of such adoption was 130, and the number of shares entitled to vote thereon was 130.

IV

The number of shares voted for such amendment was 87, and the number of shares abstaining was 43.

V

The manner in which such amendment effects a change in the amount of stated capital and the amount of stated capital as changed by such amendment are as follows:

Such amendment does not effect a change in the amount of stated capital.
