Purposes

The business which the corporation is now authorized by its charter to transact in this State, which it is also authorized to transact in its jurisdiction of incorporation, is as follows:

The corporation shall be authorized to engage in any consumer, financial and/or telecommunications business and any other lawful act or activity to the extent permitted by the Business Corporation Law of the State of New York. The corporation is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body without such consent or approval first being obtained. The territory in which the corporation's operations are to be carried on shall be anywhere in or around the world.
