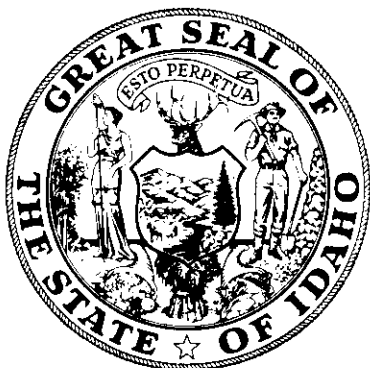

IT IS HEREBY CERTIFIED THAT:

- PRD
- (1) The name of the proposed corporation is HAIR, INC. *as per Margaret McCormick*
- (2) The period of duration of the proposed corporation is to be perpetual.
- (3) The purpose or purposes for which this corporation is formed, are as follows, to wit:

To carry on all or any of the business entitled to a corporation under Title 30, Chapter 1, Idaho Business Corporation Act, and to do all other things necessary and relating thereto:

To purchase, own, or sell real or personal property, invest in other business concerns and all other rights so prescribed under the recorded rights of a corporation:

To carry on all or any of the business of a licensed Barber/Stylist profession and to do all other things necessary and relating thereto:
