I, the undersigned natural person of the age of eighteen years or more, acting as incorporator of a corporation under the provisions of Title 30, Chapter 1, of the Idaho Code, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is ATLAS STONE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is to engage in any business for which an Idaho corporation may be organized.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares of no par value.

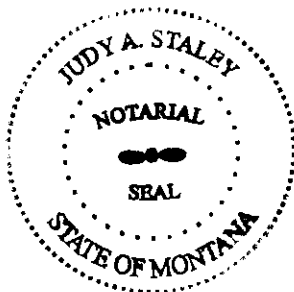


