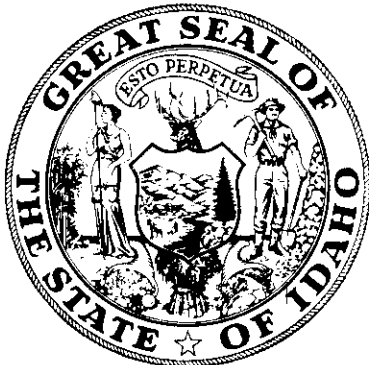

Ernest M. Jensen	Treasurer and Shareholder


3. The name of the corporation is changed to Western Visiting Nurses, Inc.
