

ARTICLES OF INCORPORATION
OF
HANSEN LOGGING COMPANY

We, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

- ARTICLE ONE NAME: The name of the corporation is "HANSEN LOGGING COMPANY."
- ARTICLE TWO PURPOSES: To engage in the general lumber business, including logging, milling and allied interests; to buy, sell and lease real and personal property, and rights therein; the transaction of any or all lawful business for which corporations may be incorporated under Idaho law.
- ARTICLE THREE DURATION: The duration of the corporation is perpetual.
- ARTICLE FOUR LOCATION: The location and post office address of the registered office of the corporation in the State of Idaho is the home of Garfield Hansen, 4 miles east of the town of Harvard, receiving mail through the Harvard Post Office in the County of Latah, Idaho 83834.
- ARTICLE FIVE STOCK: The total authorized number of par value shares of stock is One Thousand (1,000). The aggregate par value of the total authorized number of par value shares is One Hundred Dollars (\$100.00).
- ARTICLE SIX INCORPORATORS: The name and post office address of each of the incorporators is as follows:

- ARTICLE SEVEN DIRECTORS: The names of the initial directors, named by the organizers or incorporators to serve until the first election of directors are: Garfield R. Hansen, Judith N. Hansen and Richard D. Hansen.
