ARTICLES OF INCORPORATION

OF

IDAHO TRANSPER, INC.

WE, THE UNDERSIGNED, Rochelle Denise Martsch and Jerald Willis Robinson, natural persons of the age of eighteen years or more and citizens of the United States acting as incorporators under the Idaho Business Corporation Act, adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be IDAHO TRANSFER, INC.

ARTICLE II

The duration of this corporation shall be considered perpetual unless otherwise modified in writing by proper authority.

ARTICLE III

This corporation is formed for the following lawful purposes:

- (a) To operate all business functions properly authorized for a business incorporated under the laws of the State of Idaho.
- (b) To provide musical entertainment, composing and recording of music, and all other legal purposes

properly authorized for a business incorporated under the laws of the State of Idaho.

- (c) To carry on any business whatsoever that this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may be deemed, directly or indirectly, to improve the interest of this corporation, and to do all things, and to have and exercise all power conferred or permitted by law.
- (d) The foregoing statement of purposes shall be construed as a statement of both purposes and powers, and shall be liberally construed in aid of the powers of this corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in no ways limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purposes, but the purposes powers stated shall be construed distributively as each object expressed, and the enumeration as to specific powers shall not be construed as to limit in any manner aforesaid general powers, but are in furtherance of, and in addition to and not in limitation of the aforesaid general powers.

ARTICLE IV

The aggregate number of shares which this corporation shall have the authority to issue is One Hundred Thousand (100,000) shares at a par value of \$1.00 per share. All stock of this corporation shall be common, voting stock. Initially, only Sixty Thousand (60,000) shares of this stock shall be issued and outstanding as follows:

Rochelle Denise Martsch..30,000 shares Jerald Willis Robinson...30,000 shares

All remaining shares of stock shall be considered treasury stock of reserve stock and shall not be issued until proper authority for the issuance thereof is forthcoming from the corporation as per the laws of the State of Idaho. Initially, there shall be no restriction on the transfer of shares of stock from this corporation, however, the Board of Directors or the shareholders may adopt bylaws restraining the issuance of further shares under such conditions as they deem to be appropriate and reasonable.

The authorized and treasury stock of the corporation may be issued at such time, upon such terms and conditions, and for such consideration as the Board of Directors shall determine.

ARTICLE V

The shareholders shall have pre-emptive rights to acquire additional shares of the corporation prior to the issuance thereof to the general public.

ARTICLE VI

The location and post office address of the corporation's initial registered office is 198 South East Avenue, Hagerman, Idaho 83332. The name of the initial registered agent at such address is Rochelle Denise Martsch.

ARTICLE VII

The number of Directors constituting the initial Board of Directors of this corporation shall be two (2). The names and residence addresses of persons who are to serve as Directors until the first annual meeting of shareholders, or until their successors are elected and qualified are:

ARTICLE VIII

No contract other transaction between this corporation and one or more of its directors or any other person, partnership, corporation, firm, association or entity in which one or more of this corporation's directors are directors or officers or are financially interested, shall be either void or voidable because of such relationship or interest, or because such director or directors are present at the meeting of the Board of Directors, or a committee thereof in which authorizes, approves, or ratifies such contract or transaction, or because his or their votes are counted for such purpose and each such director of this corporation is hereby released from liability which might otherwise exist from such contract if: (a) the fact of such relationship or interest is disclosed or known to the Board of Directors or committee which authorizes, approves or ratifies the contract; or (b) the transaction is approved by sufficient vote or consent without counting the votes or consents of such interested director; or (c) the fact of such relationship or interest is disclosed or known to the shareholders entitled to vote and they authorize, approve, or ratify such contract or transaction by vote or written consent; or (d) the contract or transaction is fair and reasonable to the corporation. If the fact of such relationship or interest is known then the common or interested director may be counted in determining the presence of a quorum at a meeting of the Board of Directors or committee thereof which authorizes, approves or ratifies such contract or transaction.
