Box 3490, Hailey, Idaho 83333-3490. It is currently qualified as a tax-exempt organization under Internal Revenue Code Section 501(c)(3).

The remaining assets of the Nonprofit, if any, shall be distributed to another tax-exempt organization under Internal Revenue Code 501(c)(3), as determined by the Directors.

If, at the time of the Nonprofit's dissolution, The Life Church Wood River, Inc., is no longer qualified as a tax-exempt organization under Internal Revenue Code Section 501(c)(3), the Directors of the Nonprofit shall cause its remaining assets to be distributed to one or more tax-exempt organizations qualified under Internal Revenue Code Section 501(c)(3), as they shall determine.
