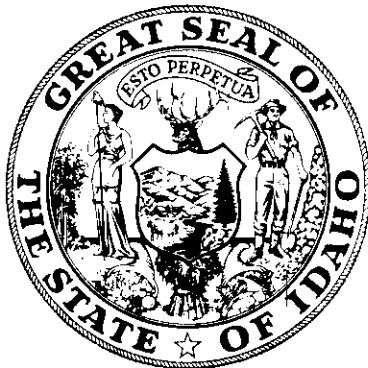

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

NELSON, ROSHOLT, ROBERTSON, TOLMAN & TUCKER, CHARTERED

Pursuant to the provisions of Sections 30-1-58 through 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The current name of the corporation is NELSON, ROSHOLT, ROBERTSON, TOLMAN & TUCKER, CHARTERED.

2. The following amendment to the Articles of Incorporation was duly adopted by the unanimous vote of shareholders of the Corporation on the 26th day of October, 1990, in the manner prescribed by the Idaho Business Corporation Act:

(a) "IT IS HEREBY RESOLVED that the Articles of Incorporation of NELSON, ROSHOLT, ROBERTSON, TOLMAN & TUCKER, CHARTERED, be, and are hereby, amended, to reflect a change in the name of the Corporation to ROSHOLT, ROBERTSON, TOLMAN & TUCKER, CHARTERED, by striking the name of NELSON, ROSHOLT, ROBERTSON, TOLMAN & TUCKER, CHARTERED, in Article I, and substituting in the place thereof, and in each of said places in which said name appears, the name ROSHOLT, ROBERTSON, TOLMAN & TUCKER, CHARTERED."

3. The aforesaid amendment to the Articles of Incorporation was adopted by the shareholders on the 26th day of October, 1990, at a special meeting of the shareholders of the Corporation.

4. The number of shares outstanding of the Corporation are 55, and all of the aforesaid shares are entitled to vote on the referenced amendment.

5. The aforesaid amendment was passed and adopted by the shareholders by unanimous vote.
