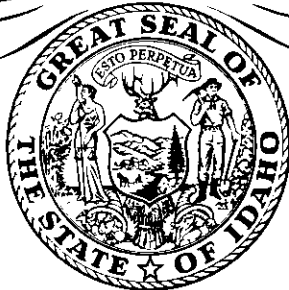

### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

One Thousand Nine Hundred **Fifty-nine** and duly recorded on Film No. **109** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for

**Fifty Years** from the date hereof, with its registered office in this State located at **Weiser,** in the County of **Washington.**

ARTICLES OF INCORPORATION

OF

RANCH-CENTER, INC.

KNOW ALL MEN BY THESE PRESENTS: That We, CRAIG ROWAN, MARY MORTENSE ROWAN, RICHARD F. HALL and BARBARA ANN HALL, all of Weiser, Idaho, each of whom is a citizen of the United States, over the age of twenty-one years and residents and citizens of the State of Idaho, desiring to form a corporation under and by virtue of the laws of the State of Idaho, do hereby associate ourselves together for said purpose and execute, acknowledge, adopt and file the following Articles of Incorporation:

ARTICLE I.

The name of this corporation shall be RANCH-CENTER, INC.;

ARTICLE II.

The names and addresses of the persons so associating themselves together for the purposes aforesaid are CRAIG ROWAN of Weiser, Idaho, MARY MORTENSE ROWAN of Weiser, Idaho, RICHARD F. HALL of Weiser, Idaho, and BARBARA ANN HALL of Weiser, Idaho, all of whom are over the age of twenty-one years;

ARTICLE III.

That the general nature of the business to be transacted by this corporation and the objects and purposes for which this corporation is formed are as follows:

To conduct a general farm and ranch supply business including but not limited to feed, seed and fertilizer; to engage in the manufacture,

1 process and sale of farm supplies and agricultural products at  
2 Weiser, Idaho, and at such other places as may hereafter be determined  
3 by the Board of Directors; to acquire by purchase or otherwise the  
4 necessary equipment, including both real and personal property; to  
5 carry on the business of manufacturing, processing and selling farm  
6 and ranch supplies and agricultural products; to enter into all  
7 necessary contracts for the purchase and sale and transportation of  
8 farm and ranch supplies and agricultural products; to sell and  
9 dispose of farm and ranch supplies and agricultural products in either  
10 wholesale or retail quantities; to act as factor, commission mer-  
11 chant, jobber or wholesaler and to do any and all things necessary  
12 to carry on the business of selling, manufacturing and processing  
13 farm and ranch supplies and agricultural products; to borrow money  
14 and to issue therefor its notes, bonds or other evidence of indebted-  
15 ness and to secure the payment of the same by pledge agreement,  
16 trustee mortgage or chattel mortgage upon any and all of the real  
17 and personal property of said corporation and generally to acquire such  
18 real and personal property as may be necessary for the purposes for  
19 which this corporation is formed; and to perform whatever additional  
20 acts may be necessary or desirable for the accomplishment of the  
21 purposes for which this corporation is organized;

26 ARTICLE IV.

27 The principal place of business and registered office of this  
28 corporation shall be Weiser, Idaho, and there may be such other  
29 subordinate and branch offices hereafter established either within  
30 or without the State of Idaho as the Board of Directors of said  
31 corporation may determine;

The authorized capital stock of this corporation shall be Fifty  
Thousand (\$50,000.00) Dollars, divided into five thousand (5,000)  
shares of the par value of Ten (\$10.00) Dollars, per share, which  
shares of stock shall be non-assessable and all certificates of  
stock issued to any purchaser of stock of this corporation shall  
have printed thereon the following words: "This stock is fully  
paid up and is non-assessable."

ARTICLE VI.

2 That Forty (\$40.00)----- Dollars, of the  
3 Capital Stock of this corporation has been subscribed by the following  
4 named persons and in the amounts set opposite their respective  
5 names, to-wit:

12 ARTICLE VII.

13 The government and management of the business of this corporation  
14 shall be vested in a Board of four (4) Directors and the said Craig  
15 Rowan, Mary Hortense Rowan, Richard F. Hall and Barbara Ann Hall  
16 shall be and constitute the first Board of Directors of this cor-  
17 poration and shall hold their offices as such until their successors  
18 are elected and qualified.

21 ARTICLE VIII.

22 The Directors, as well as the stockholders, shall have power to make  
23 such prudential By-Laws as they may deem proper for the management  
24 of the corporation, not inconsistent with the General By-Laws of the  
25 corporation, and power is hereby conferred upon the Board of  
26 Directors by a three-fourths vote of said Directors to repeal and/or  
27 amend the general By-Laws of the corporation and to adopt new  
28 general By-Laws;

30 ARTICLE IX.

31 The time of commencement of this corporation shall be the date on  
32 which a copy of these Articles of Incorporation is filed in the

1 Office of the Secretary of State of the State of Idaho, and in the  
2 Office of the County Recorder of Washington County, Idaho, and this  
3 corporation shall continue in existence for the term of fifty (50)  
4 years thereafter.


