ARTICLES OF INCORPORATION

OF

DIRECTORY CONSULTANTS, INC.

The undersigned acting as the incorporator of a corporation (hereinafter referred to as the "corporation"), under the Idaho Business Corporation Act (the "act"), adopted the following Articles of Incorporation for the corporation.

ARTICLE I

NAME

The name of the corporation is Directory Consultants, Inc.

ARTICLE II

PERIOD OF DURATION

The period of its duration is perpetual.

ARTICLE III

PURPOSES AND POWERS

Section 1. The purposes for which this corporation is organized is for directory advertising; and to do all things incident thereto or connected therewith which are not forbidden by the act, by other law, or by these Articles of Incorporation.

Section 2. The corporation shall have and exercise all powers necessary or convenient to effect its purposes, including but not limited to, the statutory powers specified in Sections 30-1-4 to 30-1-6, Idaho Code, as amended and supplemented.

ARTICLE IV

AUTHORIZED SHARES

Section 1. Number. The aggregate number of shares of common stock which the corporation shall have the authority to issue is 10,000 shares. The aggregate par value of said shares is \$10,000.00 and the par value of each share is \$1.00.

Section 2. Dividends. The holder of the common stock shall be entitled to receive, when and as declared by the Board of Directors as permitted by the act, dividends or distributions payable either in cash, in property, or in shares.

Section 3. Stock Non-accessible. The private property of the stockholders of this corporation shall not be subject to the payment of the corporate debts to any extent whatsoever, and shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business, or paying debts of the corporation.

Section 4. Voting Power. The entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of Common Stock who shall be entitled to one vote for each share of Common Stock held by them or shown by the corporate records as being owned by them.

ARTICLE V

PREEMPTIVE RIGHTS

Stockholders of the corporation shall have preemptive and preferential rights of subscription to any shares of stock of the

corporation, whether now or hereafter authorized, or to any obligations convertible into stock of the corporation, issued or sold, and the Board of Directors in issuing stock of the corporation, or obligations convertible into stock, shall first offer such issue of the obligations to the stockholders of the corporation.

ARTICLE VI

REGISTERED OFFICE

The address of the initial registered office of the corporation is 4523 Elgin, Boise, Idaho 83704, and the name of the initial registered agent is Karen Lockner.

ARTICLE VII

BOARD OF DIRECTORS

The number of the directors of the corporation shall be as specified in the by-laws. The number of directors constituting the initial Board of Directors is one (1) and the name and the address of the person who is to serve as director until the first annual meeting of shareholders or until her successors are elected and shall qualify is:




