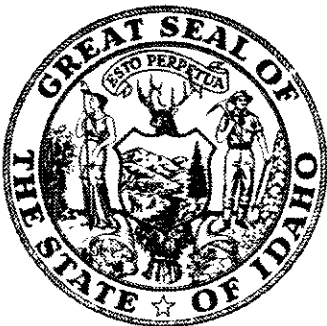

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**FIRST**

The name of the corporation is MOUNTAIN RIFLERY, INC.

**SECOND**

The period of its duration is perpetual.

**THIRD**

The purpose or purposes for which the corporation is organized are:

1. To make, manufacture, distribute, buy, sell, import, export and to otherwise deal in consumer goods made of wood, synthetic materials, metal, including but not limited to rifles, shotguns, handguns, firearms of all kinds, make, caliber and similar products to develop, patent, or otherwise legally protect and exploit new formulae and methods for the fabrication of these and similar products; and to manufacture, buy, sell or otherwise obtain and dispose of machinery, tools, accessories, and all other things necessary or useful in such business; and
2. All other things incidental thereto necessary to conduct business, together with the transaction of all other lawful business for which corporations may be incorporated under

the Idaho Business Corporation Act, Section 30-1-3.

**FOURTH**

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of \$1.00 par value common stock.

**FIFTH**

Shareholders shall have full pre-emptive rights.

**SIXTH**

Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, including provision for restriction on transfer of shares, as provided in Idaho Business Corporation Act, Section 30-1-23A.

**SEVENTH**

The address of the initial registered office of the corporation is 285 N.W. Main, Blackfoot, Idaho, and the name of its initial registered agent at such address is Murray Jim Sorensen.

**EIGHTH**

The number of directors constituting the initial Board of Directors of the corporation is one and the name and address of such person to serve as Director until the first annual meeting of shareholders, or until their successors are elected and shall qualify are:

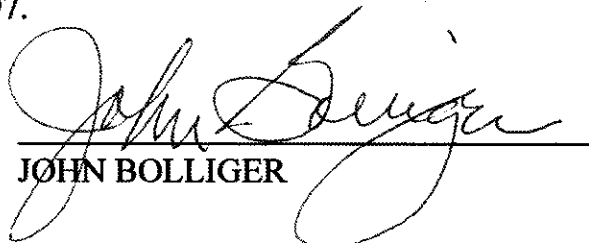
