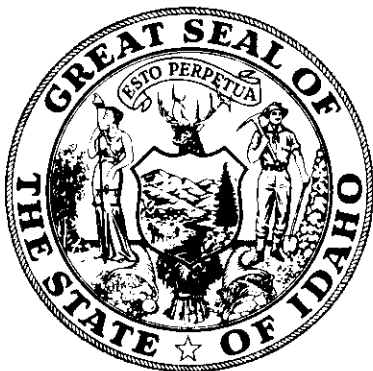

The undersigned, WALTER C. ALMQUIST, for the purpose of forming a corporation under the Idaho Non-profit Corporation Act, states:

I.

The name of the corporation shall be SPRAG POLE MUSEUM, INC.

II.

The term of existence shall be perpetual.

III.

The purposes for which the corporation is organized are as follows: To acquire by purchase or gift, assemble, preserve and exhibit in any suitable manner, records, history, material, objects, pictures and other historical data pertaining to Shoshone County, Idaho and Northern Idaho, and shall have all powers vested in it by the Non-profit Corporation Act.
