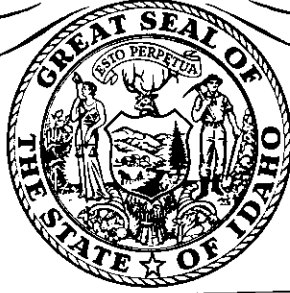

ARTICLES OF AMENDMENT

The undersigned, Roy Hanson, President, and Thora Hanson, Secretary-Treasurer, of Skyline Transportation, Inc., an Idaho corporation, do hereby certify and respectfully represent as follows:

That Skyline Transportation, Inc. was duly organized under the laws of the State of Idaho on the 12th day of March, 1964; that a meeting of stockholders of Skyline Transportation, Inc. was duly called by the Secretary by giving notice thereof prior to the date set for such meeting to such stockholders, and that each stockholder entitled to notice has filed a written assent waiving notice of the time, place and purpose of a meeting of stockholders to vote upon an amendment to the articles of incorporation, with such written assents being filed with the records of the meeting.

That such stockholders meeting of Skyline Transportation, Inc. was held on the 1st day of May, 1964, at Shelley, Bingham County, Idaho, at which all of the shareholders of said corporation were present in person and acted throughout; that by the unanimous vote of those present at said meeting, which represents a vote of the holders of one hundred per cent of the voting power of all shareholders, there was adopted a resolution amending the articles of incorporation as hereinafter set forth,

That the resolution adopted by the shareholders amending the articles of incorporation is as follows:

RESOLVED, That Article II of the Articles of Incorporation of Skyline Transportation, Inc. be amended to read as follows:

ARTICLE II

The location and post office address of the corporation's registered office in the State of Idaho is Route 4, Box 329-A, Idaho Falls, Bonneville County, Idaho, but branch places of business, each complete in itself, for the conducting and carrying on of any part of the business of the corporation, or the whole thereof, may be established at such other places, whether within or without the State of Idaho and within or without the United States of America.

FURTHER RESOLVED, that the President and Secretary-Treasurer of the corporation be, and they hereby are, authorized, directed and empowered to take the necessary action to accomplish the

Amendment of the Articles of Incorporation as herein provided.
