





ARTICLES OF AMENDMENT

The shareholders of Retail Credit Company, a corporation organized and existing under the laws of the State of Georgia, did on December 29, 1976 by unanimous consent, adopt an amendment to the Articles of Incorporation of said corporation as follows:

WHEREAS, it is now deemed expedient to change the name of the Corporation, be it

RESOLVED, that the Articles of Incorporation be amended so as to change the name of the Corporation from Retail Credit Company, its present name, to Equifax Services Inc., and to that end Article I be amended to read as follows:

"The name of the corporation is Equifax Services Inc." and that the officers of the Corporation hereby are empowered and directed to execute and deliver in the name of the Corporation such instruments and documents as they may consider necessary or advisable to effect the said change of corporate name.

Said amendment was adopted by unanimous consent by the holders of one thousand (1000) shares, there being one thousand (1000) outstanding and entitled to vote thereon. The vote of a majority of shareholders entitled to vote is required to amend the Articles of Incorporation.






