ARTICLES OF INEORPORATION OF PHILLIPS INDUSTRIES, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age and citizens of the United States of America, and residents of the State of Idaho, do hereby voluntarily associate ourselves together for the purpose of forming a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of the State of Idaho, and do hereby certify as follows:

I.

That the name of the corporation is PHILLIPS INDUSTRIES, INC.

II.

That the purposes for which said corporation is formed are as follows: to conduct a general business for the buying, selling and marketing of all types of grain produce and agricultural products and all general merchandise, including but not limited to coal, petroleum products, fertilizers and all types of consumer goods and services; to perform repairs and services of all types; to prepare, manufacture and market all types of feed for farm animals, flour for human consumption; to operate grain elevators and flour mills andd storage facilities for all types of grain and grain products; for the further purpose of hauling for hire all types of produce, goods and wares either as common carrier or as private carrier and for that purpose to secure the necessary licenses; to buy, sell, build or erect all types of buildings, including but not limited to farm storage buildings; to burther sell, market or transport all types of goods used by the general public; to offer to the general public such services as may be necessary to

fulfill the best interests of the business and to do all sundry things that a general business might do under similar circumstances.

To own, rent, lease, or maintain any building or buildings necessary for the housing and carrying on the purposes of this corporation.

To own, rent, lease or maintain any and all personal property incidental to the carrying on the purposes of the business.

To acquire, own, hold, sell, lease, purchase, mortgage or otherwise dispose of any property, real or personal, necessary to the operation of PHILLIPS INDUSTRIES, INC.

To deal in its own stock, borrow money, contract debts, make contracts and to exercise any and all such powers as a natural person can lawfully make, do, perform or exercise which may be necessary, convenient or expedient for the accomplishment of any of its objectives or purposes, provided the same shall not be inconsistent with the laws of the State of Idaho, and that the end enumeration of such powers shall not be deemed conclusive. Such corporation shall have the power to own and acquire real and personal property of any and all descriptions necessary to the convenient carrying on of its business.
