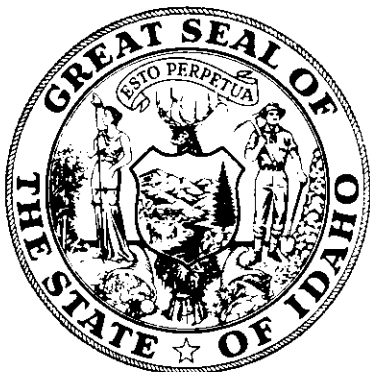

ARTICLES OF AMENDMENT

OF

CHRISTIAN SCIENCE SOCIETY OF MOSCOW, IDAHO

Pursuant to the provisions of 30-327 of the Idaho Code Annotated, the undersigned adopts the following Restated Articles of Incorporation which also amends said Articles of Incorporation:

1. The name of the corporation is the CHRISTIAN SCIENCE SOCIETY OF MOSCOW, IDAHO.

2. The Restated Articles of Incorporation, which amend said original Articles of Incorporation, are attached hereto as Exhibit "A." Each article of the original Articles of Incorporation is hereby restated as set forth in Exhibit "A," including the amendments to each article as set forth in Exhibit "A."

The following Restated Articles of Incorporation and amendments thereto were adopted on April 23, 1989, a quorum was present at such meeting, and said Restated Articles of Incorporation and amendments thereto received at least a majority of the votes which members present at such meeting in person or by proxy were entitled to cast.



EXHIBIT "A"

RESTATED ARTICLES OF INCORPORATION

OF

CHRISTIAN SCIENCE SOCIETY OF MOSCOW, IDAHO

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily restated and amended the Articles of Incorporation of the CHRISTIAN SCIENCE SOCIETY OF MOSCOW, IDAHO. Therefore, for the purpose of forming a non-profit corporation under the laws of the State of Idaho; and we hereby certify:

1. That the name of said corporation is CHRISTIAN SCIENCE SOCIETY OF MOSCOW, IDAHO.

2. That the purpose for which said corporation is formed is the carrying on and conducting public worship and the benevolent purposes connected therewith, according to the tenets of the religious denomination known as "Christian Scientists;" also, to acquire, hold and use all such real estate and other property as may be reasonably necessary for the purpose of carrying into effect the objects hereinbefore mentioned and to do all things that a nonprofit corporation organized under the laws of the State of Idaho may perform.

3. That the place where the principal business of said corporation is to be transacted is Moscow, Latah County, Idaho.

4. That the duration of the corporation shall be perpetual.

5. Upon dissolution, the officers of the corporation shall proceed to wind up the affairs of the corporation, realize upon its assets, pay its debts and distribute the remaining assets to the FIRST CHURCH OF CHRIST, SCIENTISTS, in Boston, Massachusetts,

and if it is not in existence, then to such charitable and nonprofit organization or organizations as are exempt from taxation under Section 501A of the Internal Revenue Code of 1954, and amendments thereto, as selected by the officers, subject to any limitations contained in state law.
