

ARTICLES of INCORPORATION of the "STONE RESERVOIR and CANAL  
COMPANY"

Know All MEN By These Presents:-That we the undersigned ~~have this~~  
a majority of whom as bona fide residents <sup>free holding</sup> of the State of Idaho-have  
this day voluntarily associated ourselves for the purpose of forming a  
corporation-under the laws of the State of Idaho.

And we Certify:-

First:-That the name of said Corporation is "The Stone Reservoir and  
Canal Company"

Second:-That the purposes for which it is formed are:-The constructing-  
and owning of Reservoirs and Canals in Oneida County Idaho-owning water  
and controlling the same for irrigating and manufacturing purposes

Third:-That the place of business of this corporation shall be "Stone  
Oneida County Idaho.

Fourth:-That the term for which it is to exist is fifty years from and  
after the date of its incorporation.

Fifth:-That the number of its directors shall be seven, and that the  
names and residences of those who are appointed for the first year
