Nelson, Presiding officer and Secretary, respectively, of EVANGELICAL LUTHERAN IMMANUEL CHURCH OF BOISE, IDAHO, (formerly Immanuel Swedish Evangelical Lutheran Church of Boise, Idaho) each being first duly sworn, on his oath deposes and says: That a regular meeting of the members of said corporation was held at the church house of said organization on January 10th, 1921, at 7:30 P.M.; that there was a quorum attending such meeting; that a majority of said quorum voted in favor of changing the name of said corporation from Immanuel Swedish Evangelical Lutheran Church of Boise, Idaho, to Evangelical Lutheran Immanuel Church of Boise, Idaho, and that Article 1 of the Articles of Incorporation read as follows, to-wit:

" ARTICLE I.

The name of said corporation is the
'EVANGELICAL LUTHERAN IMMANUEL CHURCH OF BOISE, IDAHO'".

That before said meeting notice of intention to vote on the proposition of amending the Articles of Incorporation by changing the name of said corporation was given by publication in the Idaho Sunday Statesman, a weekly paper published in the County of Ada, State of Idaho, wherein said meeting was held, in the issues of December 5th, 12th, 19th and 26th, 1920, and January 2nd and 9th, 1921; that the procedure of making the change of name was in accordance with Sections 4872 and 4873 of Idaho Compiled Statutes and in accordance with the Constitution and By-Laws of said organization.


