

ARTICLES OF AMENDMENT



to the

ARTICLES OF INCORPORATION

of

Shearson Lehman Hutton Insurance Agency of Idaho, Inc.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is <u>Shearson Lehman Hutton Insurance</u> <u>Agency of Idaho, Inc.</u>

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on <u>October 21, 1993</u> in the manner prescribed by the Idaho Business Corporation Act:
