I, the undersigned natural person of the age of 18 years or more, acting as Incorporator under Title 30, Chapter 1, Idaho Code, hereby submit the following Articles of Incorporation.

**ARTICLE I: Name of Corporation**

The name of the corporation shall be as follows: ROMNEY SERVICES, INC.

**ARTICLE II: Duration**

The duration of this corporation is perpetual, provided, however, that the corporation may be dissolved at any time according to law.

**ARTICLE III: Corporate Purposes**

All shares of stock in the company are assignable and any stockholder may sell, assign or transfer his or her shares and certificate or certificates of stock at pleasure, provided that no member can sell, assign, give or transfer to another without first offering his or her shares for sale or gift to the other stockholders and giving them a reasonable opportunity to purchase or accept. Further, no such transfer, gift or assignment shall be valid unless and until it shall have been entered upon the books of the company and the older certificate or certificates shall have been surrendered for cancellation to the secretary and a new certificate or certificates issued in lieu of the same.


