of the

KNOW ALL MEN BY THESE PRESENTS, that
we, the undersigned, have this day voluntarily associated
ourselves together for the purpose of forming a corporation
under the laws of the State of Idaho, and for such purpose we
make and sign the following Articles, to-wit:--

AND WE HEREBY CERTIFY

1

The name of said Corporation is hereby declared to
be The Saint Joe Transportation Company.

2

That the purposes for which it is formed are,

To carry on and conduct a general freight and
passenger transportation business on Lake Coeur d'Alene and
all waters tributary thereto, and also to carry on and con-
duct and own a general steamboat and sail boat business and
barge business and also for the purpose of constructing and
maintaining such general boat and barge business and of sell-
ing and renting, making, constructing and buying steam, sail,
and row boats of every kind, class and description and to
build and maintain wharves, warehouses, tramways, and rail-
road switches for the proper conduct and the carrying on in
connection with said business, and to buy and sell any and
all lands that may be necessary for the legitimate purposes
of said corporate business.

That the place where the principal place of busi-
ness of said Corporation is to be transacted shall be at the
Town of Coeur d'Alene, Kootenai County, Idaho, and with the
powers to establish other branch places, if found necessary,
for the purpose of carrying on the business of said Corpora-
tion.

That the term for which it is to exist is Fifty (50) years from and after the date of its Incorporation.

That the number of Directors of said Corporation shall be Five (5) and that the names and residence of those who are appointed for the first year, or until the first general election of Directors by the stock-holders, as may be fixed by the By-Laws, are as follows, to-wit.

The amount of the capital stock of this Corporation shall be Twenty Thousand (20,000) dollars, divided into Twenty Thousand shares (20,000) of the par value of One Dollar (\$1.00) per share.

The amount of the Indebtedness of the Corporation shall at no time exceed the sum of \$2,500 unless specially provided by a three-fourths vote of the entire subscribed stock
