KNOW ALL MEN BY THESE PRESENTS: THAT WE, THOMAS J. PAYNE,  
AND ANDREE L. LAMOTHE, BEING NATURAL PERSONS AND CITIZENS OF THE  
UNITED STATES OF AMERICA, DESIRING TO ASSOCIATE OURSELVES AS A  
CORPORATION UNDER THE NAME AS ABOVE SET FORTH, FOR THE PURPOSE  
OF BECOMING A BODY CORPORATE AND POLITIC UNDER AND BY VIRTUE OF  
THE LAWS OF THE STATE OF IDAHO, AND IN ACCORDANCE WITH THE  
PROVISIONS OF THE LAWS OF SAID STATE, DO HEREBY MAKE, EXECUTE AND  
ACKNOWLEDGE THIS CERTIFICATE IN WRITING OF OUR INTENTIONS TO  
BECOME A BODY CORPORATE UNDER AND BY VIRTUE OF SAID LAWS.

#### ARTICLE 1.

##### CORPORATE NAME

#### ARTICLE 2.

##### PURPOSES AND OBJECTS

THE NATURE OF THE BUSINESS AND THE OBJECTS AND PURPOSES  
PROPOSED TO BE TRANSACTED, PROMOTED AND CARRIED ON, ARE TO DO ANY  
AND ALL THINGS HEREIN MENTIONED AS FULLY AND TO THE SAME EXTENT  
AS NATURAL PERSONS MIGHT OR COULD DO, AND IN ANY PART OF THE  
WORLD, TO-WIT:

##### SECTION 2.01

TO ENGAGE IN THE GENERAL DESIGN AND CONSTRUCTION BUSINESS  
AND ALL ITS BRANCHES, AND ENTER INTO ALL MATTERS AND THINGS  
CONTAINED IN THE FIELD OF GENERAL DESIGN AND CONSTRUCTION;

TO RENDER DESIGN SERVICE REQUIRED IN THE ERECTION,  
ENLARGEMENT, ALTERATION, OR REPAIR OF ANY BUILDING, WHERE SUCH  
BUILDING IS TO BE USED, OR IS USED, AS A SINGLE OR MULTIPLE  
FAMILY RESIDENCE NOT EXCEEDING TWO STORIES IN HEIGHT, OR AS A  
FARM BUILDING, OR FOR THE PURPOSE OF OUTBUILDINGS OR AUXILIARY  
BUILDINGS IN CONNECTION WITH SUCH RESIDENTIAL OR FARM PREMISES;

THE RENDERING OF ANY DESIGN SERVICE REQUIRED IN THE  
ERECTION, ENLARGEMENT, ALTERATION OR REPAIR OF ANY BUILDING WHICH  
DOES NOT INVOLVE THE PUBLIC HEALTH OR SAFETY TO ENGAGE IN THE  
GENERAL INTERIOR DESIGN BUSINESS AND ALL ITS BRANCHES, AND IN

THAT CAPACITY TO DO AND ENTER INTO ALL MATTERS AND THINGS  
CONTAINED IN THE FIELD OF GENERAL INTERIOR DESIGN;

TO ENGAGE IN THE GENERAL LANDSCAPE, DESIGN AND GENERAL  
CONSTRUCTION BUSINESS AND ALL ITS BRANCHES, AND IN THAT CAPACITY  
TO DO AND ENTER INTO ALL MATTERS AND THINGS CONTAINED IN THE  
FIELD OF GENERAL LANDSCAPE, DESIGN AND GENERAL CONSTRUCTION;

TO ENGAGE IN THE BUSINESS OF SITE PLANNING, REGIONAL  
PLANNING, LAND USE AND ECOLOGICAL PLANNING OR ANY OTHER TYPE OF  
PLANNING IN ANYWISE ASSOCIATED THEREWITH;

TO ACT AS A GENERAL CONTRACTOR OR SUBCONTRACTOR FOR THE  
CONSTRUCTION, REPAIRING AND REMODELING OF BUILDINGS, PUBLIC WORKS  
OF ALL KINDS, AND FOR THE IMPROVEMENT OF REAL ESTATE, AND THE  
DOING OF ANY AND ALL OTHER BUSINESS AND CONTRACTING INCIDENTAL  
THERETO, OR CONNECTED THEREWITH, AND THE DOING AND PERFORMING OF  
ANY AND ALL ACTS OR THINGS NECESSARY, PROPER OR CONVENIENT FOR OR  
INCIDENTAL TO THE FURTHERANCE OR THE CARRYING OUT OF THE POWERS  
OR PURPOSES HEREIN MENTIONED;

TO CONDUCT ANY AND ALL LAWFUL BUSINESSES THAT ARE PERMITTED  
IN THE STATE OF IDAHO, OR THE UNITED STATES OF AMERICA.

TO PURCHASE, OR IN ANY WAY ACQUIRE FOR INVESTMENT OR FOR  
SALE OR OTHERWISE, LANDS, CONTRACTS FOR THE PURCHASE OR SALE OF  
LANDS, BUILDINGS, IMPROVEMENTS, AND ANY OTHER REAL PROPERTY OF  
ANY KIND OR ANY INTEREST THEREIN, AND AS THE CONSIDERATION FOR  
SAME TO PAY CASH OR TO ISSUE THE CAPITAL STOCK, DEBENTURE BONDS,  
MORTGAGE BONDS, OR OTHER OBLIGATIONS OF THE CORPORATION, AND TO  
SELL, CONVEY, LEASE, MORTGAGE, DEED IN TRUST, TURN TO ACCOUNT, OR  
OTHERWISE DEAL WITH ALL OR ANY PART OF THE PROPERTY OF THE  
CORPORATION; TO MAKE AND OBTAIN LOANS UPON REAL ESTATE, IMPROVED  
OR UNIMPROVED, AND UPON PERSONAL PROPERTY, GIVING OR TAKING  
EVIDENCES OF INDEBTEDNESS AND SECURING THE PAYMENT THEREOF BY  
MORTGAGE, TRUST DEED, PLEDGE OR OTHERWISE, AND TO ENTER INTO  
CONTRACTS TO BUY OR SELL ANY PROPERTY, REAL OR PERSONAL; TO BUY  
AND SELL MORTGAGES, TRUST DEEDS, CONTRACTS, AND EVIDENCES OF  
INDEBTEDNESS; TO PURCHASE OR OTHERWISE ACQUIRE, FOR THE PURPOSE  
OF HOLDING OR DISPOSING OF THE SAME, REAL OR PERSONAL PROPERTY OF  
EVERY KIND AND DESCRIPTION, INCLUDING THE GOOD WILL, STOCK,  
RIGHTS, AND PROPERTY OF ANY PERSON, FIRM, ASSOCIATION, OR  
CORPORATION, PAYING FOR THE SAME IN CASH, STOCK, OR BONDS OF THIS  
CORPORATION; AND TO DRAW, MAKE, ACCEPT, ENDORSE, DISCOUNT,  
EXECUTE, AND ISSUE PROMISSORY NOTES, BILLS OF EXCHANGE, WARRANTS,  
BONDS, DEBENTURES, AND OTHER NEGOTIABLE OR TRANSFERABLE  
INSTRUMENTS, OR OBLIGATIONS OF THE CORPORATION, FROM TIME TO  
TIME, FOR ANY OF THE OBJECTS OR PURPOSES OF THE CORPORATION  
WITHOUT RESTRICTION OR LIMIT AS TO AMOUNT.

TO DO ANY AND ALL OTHER LAWFUL BUSINESS IN ANYWISE

AFFILIATED WITH OR ASSOCIATED THEREWITH.

SECTION 2.02

TO ACQUIRE, OWN, OPERATE, SELL, EXCHANGE, LET OR LEASE FACILITIES FOR THE CONDUCT OF SAID BUSINESS WITHIN THE STATE OF IDAHO OR OUTSIDE THE STATE OF IDAHO.

SECTION 2.03

TO BORROW MONEY FOR THE PURPOSES OF THIS CORPORATION; TO ISSUE BONDS, NOTES AND DEBENTURES AND OTHER EVIDENCES OF INDEBTEDNESS THEREFORE AND TO SECURE THE SAME BY MORTGAGE OR PLEDGE OF PERSONAL PROPERTY, INCLUDING THE INCOME OF SAID CORPORATION OR BY MORTGAGE OF REAL PROPERTY EXECUTED IN TRUST OR OTHERWISE. ALL OR ANY PORTION OF THE REAL OR PERSONAL PROPERTY OF THE CORPORATION MAY BE SO PLEDGED, MORTGAGED OR HYPOTHECATED.

SECTION 2.04

TO BUILD ANY OR ALL BUILDINGS, STRUCTURES OR WAREHOUSES NECESSARY OR CONVENIENT FOR THE CONDUCT OF THE BUSINESS OF SAID CORPORATION OR OTHERS OR TO ACQUIRE THE SAME BY PURCHASE, LEASE OR OTHERWISE.

SECTION 2.05

TO PURCHASE, LEASE OR OTHERWISE ACQUIRE, IN WHOLE OR IN PART, THE BUSINESS, GOODWILL, RIGHTS, FRANCHISES AND PROPERTY OF EVERY KIND AND TO TAKE OVER THE WHOLE OR ANY PART OF THE ASSETS OR LIABILITIES OF ANY PERSON, FIRM, ASSOCIATION OR CORPORATION ENGAGED IN OR AUTHORIZED TO BE CONDUCTED BY THIS CORPORATION OR OWNING PROPERTY NECESSARY OR SUITABLE FOR ITS PURPOSES AND TO PAY FOR THE SAME IN CASH, IN THE STOCK OR BONDS OF THIS CORPORATION OR OTHERWISE; TO HOLD OR IN ANY MANNER DISPOSE OF THE WHOLE OR ANY PART OF THE BUSINESS OR PROPERTY SO ACQUIRED AND TO EXERCISE ALL THE POWERS NECESSARY OR INCIDENTAL TO THE CONDUCT OF SUCH BUSINESS.

SECTION 2.06

TO ENTER INTO ANY CONTRACT, COOPERATIVE AGREEMENT OR PROFIT-SHARING PLAN WITH ITS OFFICERS OR EMPLOYEES THAT THE CORPORATION MAY DEEM ADVANTAGEOUS OR EXPEDIENT OR OTHERWISE TO REWARD OR PAY SUCH PERSONS FOR THEIR SERVICES AS THE DIRECTORS MAY DEEM FIT.

SECTION 2.07

TO PURCHASE OR OTHERWISE ACQUIRE, OWN, HOLD, MORTGAGE, PLEDGE, SELL, ASSIGN, TRANSFER OR OTHERWISE DISPOSE OF SHARES OF

THE CAPITAL STOCK OF THIS CORPORATION OR EVIDENCES OF INDEBTEDNESS OF ANY KIND OR ANY KIND OR NATURE CREATED BY ANY CORPORATION OR CORPORATIONS, WHEREVER ORGANIZED, WHETHER PUBLIC OR PRIVATE.

#### SECTION 2.08

TO EXERCISE GENERALLY THE POWERS CUSTOMARILY EXERCISED BY BUSINESS CORPORATIONS AND PARTICULARLY THE POWERS PROVIDED BY THE LAWS OF THE STATE OF IDAHO REFERRING ESPECIALLY TO SECTION 30-1-4 OF THE IDAHO CODE IN ANY STATE OF THE UNITED STATES AND THROUGHOUT THE WORLD.

#### SECTION 2.09

TO CARRY ON ANY OTHER BUSINESS OR TO DO ANYTHING IN CONNECTION WITH THE OBJECTS AND PURPOSES ABOVE MENTIONED THAT MAY BE NECESSARY OR PROPER TO ACCOMPLISH SUCCESSFULLY OR PROMOTE THE SAID OBJECTS AND PURPOSES. THE FOREGOING CLAUSES, BY REASON OF THE SPECIFIC ENUMERATION OF POWERS, SHALL NOT BE HELD TO RESTRICT THE POWER OF THE CORPORATION TO DO ANY OF THE THINGS WITHIN THE PURVIEW OF ITS GENERAL PURPOSE.

THE DURATION OF THE CORPORATION SHALL BE PERPETUAL.

#### CAPITAL STOCK

## ARTICLE 6.

## CLASSES OF STOCK

THE STOCK OF THE CORPORATION IS DIVIDED INTO 1,000 SHARES OF COMMON STOCK ALL WITH EQUAL RIGHTS AND PRIVILEGES AND PREEMPTIVE RIGHTS.

## ARTICLE 7.

## DIRECTORS

THE AFFAIRS OF THE CORPORATION WILL BE MANAGED BY A BOARD CONSISTING OF ONE DIRECTOR OR MORE IF SPECIFIED BY THE BY-LAWS. DIRECTORS OF THE CORPORATION SHALL BE ELECTED AT THE ANNUAL MEETING OF THE SHAREHOLDERS IN THE MANNER DETERMINED BY THE BY-LAWS. DIRECTOR VACANCIES SHALL BE FILLED IN THE MANNER PROVIDED BY THE BY-LAWS. THE INITIAL BOARD OF DIRECTORS SHALL CONSIST OF THE INCORPORATOR HEREOF, WHO IS TO SERVE AS A DIRECTOR UNTIL THE FIRST ANNUAL MEETING OF SHAREHOLDERS OR UNTIL ANY SUCCESSOR BE ELECTED AND QUALIFIES.


