KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of legal age and citizens of the United States of America, in order to form a corporation under the Idaho Business Corporation Act, do hereby certify as follows:

NAME

The name of this corporation shall be TEMPRO, INC..

-II-

REGISTERED OFFICE
