ARTICLES OF INCORPORATION

of

MODERN DRUG CENTER, INC.

(In triplicate)

KNOW ALL MEN BY THESE PRESENTS:

That, we, the undersigned, WALTER R. ALLEN, WILMA M. ALLEN and CHRIS ROHOLT, all of whom are citizens of the United States of America, are of full legal age and are each bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation, and do by these Articles of Incorporation hereby form and incorporate under the laws of the State of Idaho, and to this end do adopt the following certificate of incorporation:

I.

That the name of the corporation shall be "MODERN DRUG CENTER, INC."

II.

That the purposes for which said corporation is formed are as follows:

To carry on and conduct a general wholesale and retail drug business; to manufacture, buy, sell, import, export, trade, and deal in drugs, medicines, proprietary articles, druggists' sundries, chemicals, extracts, tinctures, pomades, ointments, liniments, toilet articles, perfumeries, surgical apparatus, physicians' and hospital supplies, paints, oils, dyestuffs, glassware, fancy goods, and general merchandise.

To acquire and operate ice cream and soda fountains, together with all of the fixtures, equipment, machinery, and dishes necessary in connection with a restaurant and ice cream and soda fountain business.

To manufacture, purchase, and sell notions, toys, department store supplies, and merchandise of every kind, and to receive and sell the same as agent or on commission.

To manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, assign and transfer, or otherwise dispose of, to invest, trade, deal in and deal with, goods, wares, and merchandise and real and personal property of every class and description.

To perform such services and engage in such activities which are necessary, expedient or convenient to carry out any and all of the foregoing described purposes.

III.

That the duration of this corporation shall be perpetual.

IV.

The registered office and post office address and the place at which the principal business of this corporation shall be conducted in the State of Idaho is the city of Coeur d'Alene, County of Kootenai, State of Idaho.

V.

That the total authorized stock of this corporation shall be Fifty Thousand and no/100 (\$50,000.00) Dollars, divided into Fifty Thousand (50,000) shares of common stock of the par value of One and no/100 (\$1.00) Dollar per share.

VI.

That the name, post office address and number of shares subscribed by each incorporator are as follows:
