ARTICLES OF INCOMPONATION

OF

KNOW ALL MEN BY TRUGE PRESENTS:

That we the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

AND WE HEREBY CERTIFY: -

First. That the name of said corporation is "Boyle Sheep Company".

Second. That the purposes for which it is formed are. To buy and sell live stock of all kinds. To own and run cattle, hogs and sheep. To buy and sell wool and hides. To own grazing rights. To buy and sell real estate. To buy and sell all kinds of farm produce. To do any and all things connected with a general live stock business. To make leans on live stock and to take security therefore. To lease live stock and to let the same either on shares or for each.

Third. That the place where its principal business is to be transacted shall be in the City of Rupert, Finnidoka County, Idaho.

Fourth. That the term for which it is to exist is fifty years.

Fifth. That the number of its Directors shall be three.

Sixth. That the amount of the capital stock of this corporation shall be Twenty Five Thousand Dollars, divided into Two Hundred Fifty Shares of the par value of One Rundred Dollars each.
