One Thousand Nine Hundred and twenty-eight and is duly recorded in Book 1-20 of Domestic Corporations, Records of the State of Idaho, and that the said articles contain the statement of facts required by Section 4696 of Idaho Compiled Statutes, to-wit:

FIRST, The name of the Corporation as aforesaid; SECOND, The purpose for which it was formed; THIRD, The place where its principal business is to be transacted; FOURTH, The term for which it is to exist; FIFTH, The number of its directors or trustees; SIXTH, The amount of its capital stock and the number of shares into which it is divided; SEVENTH, The amount of its capital stock actually subscribed and by whom.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a body politic and corporate, by the name stated in the articles, for the term of fifty years.

ARTICLES OF INCORPORATION

OF

BOYLE SHEEP COMPANY

KNOW ALL MEN BY THESE PRESENTS:

That we the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

AND WE HEREBY CERTIFY:-

- First. That the name of said corporation is "Boyle Sheep Company".
- Second. That the purposes for which it is formed are. To buy and sell live stock of all kinds. To own and run cattle, hogs and sheep. To buy and sell wool and hides. To own grazing rights. To buy and sell real estate. To buy and sell all kinds of farm produce. To do any and all things connected with a general live stock business. To make loans on live stock and to take security therefore. To lease live stock and to let the same either on shares or for cash.
- Third. That the place where its principal business is to be transacted shall be in the City of Rupert, Minnidoka County, Idaho.
- Fourth. That the term for which it is to exist is fifty years.
- Fifth. That the number of its Directors shall be three.
- Sixth. That the amount of the capital stock of this corporation shall be Twenty Five Thousand Dollars, divided into Two Hundred Fifty Shares of the par value of One Hundred Dollars each.
- Seventh. That the amount of capital stock which has been actually subscribed is Three Hundred Dollars and the following are the names of the persons by whom the same has been subscribed.
