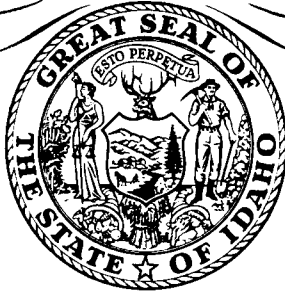

That we the undersigned full age citizens of the United States have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under Title 30, Chapter 10, Laws of the State of Idaho and we do hereby certify.

Article I
Name

This corporation shall be called Mountain Toppers Motorcycle Club Inc

Article II

Purpose and Objects

- 1 To promote better relations between Motorcyclists and the public.
- 2 To encourage and promote safe and legal riding on the street and highways.
- 3 To promote organized safe motorcycle events both competitive and social.
- 4 To promote good fellowship between all motorcyclist regardless of race, color, creed, make of machine, or social position.

Article III
Duration

The duration of this corporation shall be perpetual.

Article IV
Location and Address

The principal place of business of said corporation is to be located at 5614 West State St and shall have all mail sent to 5614 West State St Boise, Idaho

Article V

This Non profit corporation shall not have any capital stock and shall neither issue anything representing stock. The corporation shall not be operated for a pecuniary profit.

Article VI

Number of Incorporators

It shall be lawfull for five or more persons to form a **corpertive** association for any purpose where pecuniary profit is not their object.

Article VII.

Interests of Members Equal

In such an association the right and interest of all members shall be equal and no member can have or acquire a greater interest therein than any other member.

Article VIII

Directors
