I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

GEM COUNTY SHERIFF'S MOUNTED POSSE, INC.

was filed in the office of the Secretary of State on the **Eight** day
of **May**, A. D. One Thousand Nine Hundred **Sixty-four** and
is duly recorded on Film No. **128** of Record of Domestic Corporations, of the State
of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and
Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and
successors are hereby constituted a corporation, by the name hereinbefore stated, for
perpetual existence from the date hereof, with its registered office in this State located at
Emmett in the County of **Gem**
and as such are subject to the rights, privileges and limitations granted to Non-Profit Coopera-
tive Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

OF

GEM COUNTY SHERIFF'S MOUNTED POSSE, INC.

* * * * *

We, the undersigned, all of whom are residents of the State of Idaho and being citizens of the United States, being of legal age, do hereby voluntarily associate ourselves together for the purpose of forming a non-profit corporation, with no capital stock, under the authority of Idaho Code 30-1001.

ARTICLE I

The name of this corporation shall be:

GEM COUNTY SHERIFF'S MOUNTED POSSE, INC.

ARTICLE II

(a) The business, purpose and object of this club shall be:

1. To promote recreation and sport of horsemanship; to promote social activities among the members of the corporation and their guests. To promote physical and mental health and to foster good fellowship; to promote public relations and to participate in community activities; to further breeding of fine horses; to be called together as an emergency posse. To deal with any emergencies upon the call of the Governor of the State of Idaho, the Sheriff of Gem County, or any and all duly qualified law enforcement agencies.

(b) To buy, lease, hold and exercise all privileges of ownership over such real or personal property as may be necessary or convenient for the conduct and operation of the business of the corporation or incidental thereto, and to receive and distribute gifts of property of all kinds.

(c) To carry on all business whatsoever which this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or which may be calculated directly or indirectly to promote the interest of this corporation, or to enhance the value of its property or business.

(d) To borrow money; to lend money, to own real property; to own personal property; to deal in real property; to deal in personal property; to have and to exercise all the powers conferred by the laws of the State of Idaho upon corporations formed under the laws pursuant to and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be enacted or amended.

(e) To co-operate with similar associations and corporations.

(f) To have and exercise all power, privileges and rights conferred on corporations by the laws of this State and all other powers and rights incidental to carrying out the purposes for which this corporation is formed, except such as are inconsistent with the express provisions of the Act under which this corporation is incorporated.

(g) The foregoing shall be construed both as objects and powers, and the enumeration thereof shall not be held to limit or restrict in any manner the powers conferred on this corporation by the laws of the State of Idaho, all of which are hereby expressly granted.

ARTICLE III

The place where the principal business of the corporation is to be transacted is in the City of Emmett, County of Gem, State of Idaho, but the corporation may maintain offices and places of business at such other places within or without the State as the Board of Directors may determine.

ARTICLE IV

The corporation shall be nonstock and no dividends or pecuniary profits shall be declared to the members thereof. The rights and interests of all members shall be equal and no member can have or acquire a greater interest herein than any other member. Membership certificates shall be issued to each member hereof.

ARTICLE V

The general officers of said corporation shall be President, a Vice-President and a Secretary and Treasurer. The office of Secretary and Treasurer may be combined. The said officers shall perform such duties as may be prescribed by the By-Laws.

ARTICLE VI

The period of existence of this corporation shall be perpetual.

ARTICLE VII

The Board of Directors shall consist of ten members, including the immediate Past-President and they shall perform such duties as shall be prescribed by the By-Laws.

ARTICLE VIII

The said corporation shall hold it's election of officers and directors according to the manner prescribed by the adopted By-Laws.

ARTICLE IX

These articles may be amended, by a two-thirds vote of the members present at any regular or special meeting provided that

written notice of the proposed amendment or amendments has been mailed to the last known address of each member at least ten (10) days prior to the date of such meeting.

ARTICLE X
