ARTICLE I. NAME

The name of this corporation is Restoration Smile, Inc.

ARTICLE II. PURPOSE

The corporation is organized is exclusively for charitable, educational, and scientific purposes, including oral health care and surgery in underdeveloped communities and nations to indigent individuals and families. Charitable care may include the treatment of cleft lip/palate deformity, dentoalveolar disease, and general oral surgery. The corporation is organized and operated exclusively for charitable purposes and is a non-profit corporation within the meaning of Section 501(c)(3) of the Internal Revenue Code and Idaho law.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of said Code, or the corresponding provisions of any future statute of the United States. No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation; nor shall the corporation participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.


ARTICLE VII. VOTING MEMBERS

Any such assets not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or such organizations as said court shall determine which are organized and operated for such purposes.
