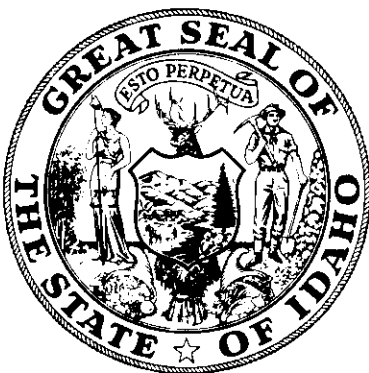

ARTICLES OF INCORPORATION
OF
COMMUNITY OPEN BIBLE CHURCH, INC

ARTICLE I

The name of this corporation is Community Open Bible Church, Inc

ARTICLE II

- A. This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law, Exclusively for religious purposes.
- B. The specific purpose of this corporation shall be the propagation and dissemination of the gospel of Jesus Christ.

ARTICLE III

The period of duration shall be perpetual.

ARTICLE IV

ARTICLE V

- A. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
- B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

ARTICLE VI

The property of this corporation is irrevocably dedicated for religious purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution of this corporation, it's assets remaining after payment, or provision for payment of all debts and liabilities of the corporation shall be turned over to Open Bible Standard Churches, Inc., an Iowa corporation, for disposition according to the said corporation's policy for extinct churches. If said corporation is then non-existent, such assets

shall be turned over to a nonprofit fund, foundation or corporation which is organized and operated exclusively for religious purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.

ARTICLE VII

Bylaws of this corporation shall consist of ARTICLE IV of the bylaws of Open Bible Standard Churches, Inc., having its place of business in Des Moines, Iowa, and such additional bylaws as may be passed by a majority vote of the members present at any business meeting of the corporation not inconsistent herewith.
