ARTICLES OF INCORPORATION

OF

SAF=ETY, INC.

A Non-Profit Corporation under the  
Laws of the State of Idaho

WE, the undersigned natural persons of the age of 18 years or more, acting as incorporators for the purpose of creating a non-profit corporation under the laws of the State of Idaho, as contained in Chapter 3 of the General Statutes of the State of Idaho, entitled "Non-Profit Corporations" and the amendments thereto, modified at I.C. 30-308, et. seq., do hereby set forth:

ARTICLE I

Name

The name of the non-profit corporation is SAF=ETY, INC.

ARTICLE II

Duration

The duration of the corporation shall be perpetual.

ARTICLE III

Purposes

The purposes for which the corporation are organized are: to exercise, promote and protect the privileges and interests of the residents of Blaine County and the City of Hailey, State of Idaho; to foster a healthy interest in the civic affairs of the community; to secure by lawful means greater economy and efficiency in government; to stimulate public interest in civic affairs; to protect and promote the people, community and businesses of Blaine County and to protect and preserve the safety of the citizens of Blaine County and to promote the peaceful, tranquil and orderly growth of Blaine County and the City of Hailey;

ARTICLE IX

Powers

The corporation shall have all the powers granted to non-profit corporations under the laws of the State of Idaho. However, notwithstanding anything herein to the contrary, the corporation shall exercise only those powers as are in furtherance of the exempt purposes of organization as set forth in the subsections of Section 501(c) of the Internal Revenue Code and all amendments thereto, under which the corporation chooses to qualify for exemption, as the same now exists or as may be amended from time to time.

ARTICLE X

Distribution or Dissolution

In the event of the dissolution of the corporation no member shall be entitled to any distribution or division of its remaining property as proceeds and any balance of any property or other money received by the association and corporation from any source, after the payment of all debts and obligations of the corporation shall be used or distributed exclusively for purposes within the intendment of Section 501(c) of the Internal Revenue Code as the same now exists or may be amended from time to time.
