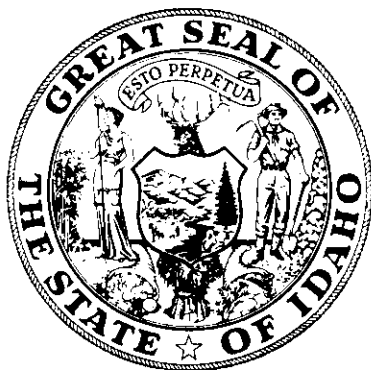


3. The notice required by Section 30-1-87, Idaho Code, was not given or necessary since the corporation has no creditors.


VOLUNTARY DISSOLUTION BY CONSENT OF SHAREHOLDER






