KNOW ALL MEN BY THESE PRESENTS:-

That we, the undersigned members of BETHEL EVANGELICAL LUTHERAN CHURCH OF FIRTH, IDAHO, DO HEREBY, in accordance with the constitution and rules of said church, and under and by virtue of the laws of the State of Idaho, incorporate ourselves and form a corporation as follows, to wit:

I.

The name of this corporation is BETHEL EVANGELICAL LUTHERAN CHURCH, INC., OF FIRTH, IDAHO.

II.

That the property of this corporation includes and comprises Block Two (2) and Lots One (1) to Four (4) and Seven (7) to Twelve (12) of the Firth McMullen Addition.

III.

That this corporation is formed for the purpose of promoting and enabling the members to teach and expound the gospel according to the tenets of faith held by them; to purchase and own such real estate and other property as may be necessary for the purposes of said church: to receive donations; to receive, manage, take and hold real estate and personal property, by gift, grant, devise or bequest. And that pecuniary profit is not the object of this corporation.

IV.

That the place where its registered office shall be located shall be P. O. Box 208 in the Village of Firth, County of Bingham, State of Idaho. And that the Registered Agent shall be Rev. Charles R. Paulson. And the term for which said corporation shall exist is fifty (50) years.

V.

That the number of trustees shall be not less than three (3) nor more than twelve (12). The names of those who are appointed and their residence address, and who shall hold offices of Trustees till their successors are elected and shall have qualified are as follows:
