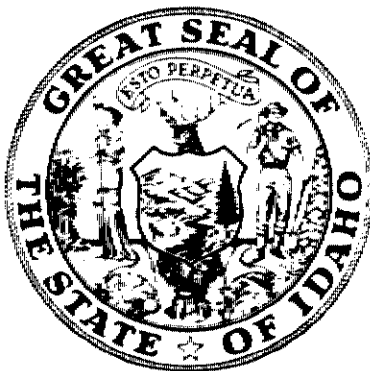

ARTICLES OF DISSOLUTION

PURSUANT TO THE IDAHO NON-PROFIT CORPORATION ACT

AND SECTION 30-1-92 OF THE IDAHO BUSINESS CORPORATION ACT

OF

SPRING MEADOW PHASE I LOCAL ASSOCIATION, INC.

Pursuant to the provisions of the Idaho Non-Profit Corporation Act and Section 30-1-92 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Dissolution for the purpose of dissolving the corporation. The Articles were adopted at a meeting of members occurring on the 30th of May, 1990 with unanimous approval.

FIRST: The name of the Corporation is Spring Meadow Phase I Local Association, Inc., and its post office address is 380 East Park Blvd., Boise, Idaho 83702.
