ARTICLES OF INCORPORATION
OF
SAMONS OF IDAHO, INC.

The undersigned, acting as the incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: That the name of the corporation is:

SAMONS OF IDAHO, INC.

SECOND: That the period of its duration is perpetual.

THIRD: That the purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: That the aggregate number of shares which the corporation shall have authority to issue is one hundred thousand (100,000), all of one class, of the par value of \$1.00 per share.

FIFTH: That the address of the initial registered office of the corporation is 1592 East 17th Street, Idaho Falls, Idaho 83404; that the name of its initial registered agent at such address is: Ronald Wayne Folsom.

SIXTH: The Shareholders of the corporation may, from time to time, distribute to themselves out of capital surplus of the

corporation a portion of its assets, in cash or property, subject to the following provisions:

(a) No such distribution shall be made at a time when the corporation is insolvent or when such distribution would render the corporation insolvent.

(b) No such distribution shall be made unless it is authorized by the affirmative vote of the holders of a majority of the outstanding shares.

(c) Each such distribution, when made, shall be identified as a distribution from capital surplus and the amount per share disclosed to the Stockholder receiving the same concurrently with the distribution thereof.




Dear Sally:

You have indicated that there is presently a corporation using the name "Samons, Inc." and that it would be necessary to obtain the consent of the principals of such corporation for my clients use of the name of "Samons of Idaho Inc."

Please be advised that Samons, Inc., as Seller, and my clients, Ronald Folsom and Leslie Folsom (as well as Ivan L. Ashment who is now deceased) doing business as Samons of Idaho Falls, as Buyers, entered into an agreement dated March 7, 1983 wherein said Buyers purchased all Idaho Falls assets of Samons, Inc. for cash on closing. The following is quoted from said agreement and constitutes what we interpret to be a consent:

"4. LIMITED AND REVOCABLE LICENSE TO USE THE NAME OF SAMONS. Seller does hereby license the Buyers to use the name of "Samons" as a portion of its name for operations in Idaho Falls, Idaho, and in any other locations with the prior written consent of Seller."
