Article 1: The name of this corporation shall be: ELEVATION WORSHIP CENTER INC.

Article 2: The purpose for which the corporation is organized:

A. This Corporation is a religious corporation and is not organized for private gain of any person. It is organized under The Nonprofit Religious Corporation Law exclusively for religious purposes. This corporation is organized exclusively for charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code

B. The specific purpose of this corporation is to operate a Church for religious purposes and be able to contract, rent, buy or sell personal or real property and to have and exercise all rights and powers conferred on a non-profit corporation under the laws of Idaho.

Article 9: Propaganda: No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

Article 10: Inure - Clause: The property of this corporation is irrevocably dedicated to religious and charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.
