## ARTICLES OF INCORPORATION OF SAGE GYMNASTICS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation.

#### ARTICLE I

NAME: The name of the Corporation is Sage Gymnastics, Inc.

#### ARTICLE II

DURATION: The duration of the corporation shall be perpetual.

#### ARTICLE III

PURPOSE AND POWERS: The purpose or purposes for which the corporation is organized are:

- (a) To engage in the business of offering gymnastic instruction and classes.
- (b) To have all rights and powers normally ascribed to and incidental to said primary purpose and to business operations in general including, but not limited to; raising capital and operating monies; entering into, performing and carrying out contracts; entering into joint ventures or limited partnerships; acquiring, by purchase or otherwise, maintaining, developing, improving, financing, mortgaging, selling, renting, or exchanging such real property, equipment and other facilities as are needed by the Corporation, and to undertake all business transactions, functions and service ordinary and necessary to the business, as set forth above, or any other lawful business authorized under the laws of this State.
- (c) To have as its purpose the the pursuit and development of any other business opportunities that relate to its primary purpose, as set forth above.
- (d) To engage in any other lawful activities permitted by the Idaho Business Corporation Act.

#### ARTICLE IV

AUTHORIZED SHARES: The aggregate number of shares of common voting stock which the Corporation shall have authority to issue is 10,000, all of which shall have a par value of \$1.00 per share.

#### ARTICLE V

REGISTERED OFFICE AND AGENT: The address of the Corporation's initial registration office is 1250 Madrona St. North, Twin Falls, ID 83301 and the name of its initial registered agent at such address is Robert B. Van Wagoner.
