ARTICLES OF INCORPORATION OF PALOUSE DANCE THEATRE, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

<u>FIRST - NAME OF CORPORATION</u>: The name of the corporation is Palouse Dance Theatre, Inc..

SECOND - NONPROFIT CORPORATION: The corporation is and shall be non-profit. No part of the corporation's income is to be devoted to other than the purposes hereinafter set forth. The corporation is organized and shall be operated for educational purposes as meant in Section 501 (c)(3) of the United States Internal Revenue Code and all amendments thereto, as it may apply to the activities of this corporation.

THIRD - DURATION: The duration of this corporation shall be perpetual.

FOURTH - PURPOSE: The purpose of the corporation is fraternal and educational; it is organized to provide for people of all ages a comprehensive program in Dance, Theatre and Physical Conditioning that encourages physical, mental and personal growth.

<u>FIFTH - MEMBERSHIP</u>: This corporation is not organized for profit and shall have no capital stock and shall be composed of members rather than shareholders.

<u>SIXTH - GOVERNMENT</u>: The government of this corporation shall be as stated in its by-laws, which shall be adopted by the first directors of this corporation.

SEVENTH - REGISTERED OFFICE: The location and street address of the corporation and its registered agent is 419 Styner Avenue, Moscow, Idaho 83843. The name of the registered agent is Sally Quinn.
