

Designation of Agent and Acceptance of the Provisions of the Constitution of the State of Idaho.

Know all Men by These Presents:

That Wells Fargo & Company, (then territory) of

accept the provisions of the Constitution of the State of Idaho for all the intents and purposes con-
templated by the provisions thereof, relating to such acceptance by other than municipal corporations.
(Article XI, Section 7, Constitution of Idaho.)
