ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators under the incorporation Act, hereby adopt the incorporation. Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is SUNNYSIDE TACK & WESTERN WEAR, INC.

ARTICLE TWO

DURATION

The duration of the corporation shall be perpetual.

ARTICLE THREE

PURPOSES AND POWERS

The purposes of the corporation and its powers are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

STOCK
